# STANDING ORDER APPLICATION FORM TERMS & CONDITIONS

**1.1. "OUI Radio"** is a non profit Christian Web Radio Station owned by **OUI-Prod Ltd**, a private company limited by shares incorporated in Mauritius on the 24<sup>th</sup> January 2020, bearing Company No.: 170278, located at 129, John Kennedy Avenue, Vacoas, PW, 74107, Mauritius.

**1.2. "PLEDGE DONOR"** is a person donating on a regular monthly basis a fixed amount for at least 3 consecutive months in support of OUI Radio's activities.

## 2. Automatic donations by a bank transfer.

**2.1.** Monthly donations by a bank transfer are made when the **PLEDGE DONOR** signs a direct debit agreement/standing order form, indicating **OUI-Prod Ltd** as the beneficiary, with a bank in which the **PLEDGE DONOR** has opened a checking/savings account and sets out the amount the **PLEDGE DONOR** wishes to donate every month.
